4. Action taken since the last Parish Council Meeting

Quarry:

Following the last Quarry Liaison Meeting, the Chairman, Councillor Sayers and Gareth Woodyer visited the quarry on 21 July 2022. Their observations and agreed outcomes were as follows:

- We were impressed by the running of the quarry in general and their attention to both H&S and dust suppression in particular.
- They have an extensive heavy duty sprinkler system that covers all of the main thoroughfares throughout the quarry, a water bowser that targets active work areas and sprinklers specifically for rock crushing areas. All were in operation when we visited as it was a hot dry day, as so many have been this summer.
- We were left in no doubt that both noise and dust suppression is something they take very seriously.
- There are well documented legal limits for noise levels and at the moment they appear to be operating within these.
- The required standards for the level of dust emissions is less clear and Tony Tait has agreed to seek guidance on this and come back to us with an answer.
- He has agreed to share all dust monitoring data with us from now on.
- He is also having the dust samples analysed to establish how much of it is actually dust from the quarry and will share the report with us.
- He confirmed that although the lease runs until 2042, he does not anticipate any extraction south of the road for at least 12 years and more likely 15. At such a point mobile processing units would be used which would reduce both the visual impact with much lower stone stacks and dust levels by processing stone next to the face rather than trucking it to a central crushing unit as they do now.

Cemetery Extension:

Councillors have undertaken a cemetery site visit to confirm the scope of the works required to prepare the proposed extension to the cemetery for future use. Quotes are currently being sought for Phase 1 and 2 of the proposed works comprising the removal

of the hedge and fence line at the bottom of the existing cemetery area and for running a pasture topper over that area. 2 quotes for that work have been received and are currently being evaluated. A quote has also been obtained for the maintenance of that area during 2023 once the works have been carried out.

Hillcrest Development:

Following receipt of notification that the proposed development of land at Hillcrest had been granted planning permission, a complaint (attached in full to the Clerk's report at item 5 on the agenda) has been submitted to Richmondshire District Council about how various aspects of the application process have been handled. Richmondshire District Council's response to that complaint is included at item 10 on the agenda.

Village Play Area:

Richmondshire District Council has continued to provide the Clerk with copies of the monthly Play equipment reports, which have been forwarded to Councillors. Councillor Higham, Gareth Woodyer and Patrick Earle have recently met onsite with RDC Officers and Councillor Higham will report on progress at the meeting.

Village Emergency Plan

Following an initial meeting with Joe Rushbrook from the Resilience Team at North Yorkshire County Council, work has started on the development of a Resilience Plan for the village. Mellbecks Parish Council, who have a Plan in place have offered their support for this process and on 30 November Councillor Knight will attend a training session with that Parish Council to test their Plan in practice and will report on his attendance at the meeting.

Trees in The Stanney

The Bolton Estate has completed tree felling and tree maintenance works in The Stanney.
